

e-Leasing Direct Privacy Policy

Mitsubishi HC Capital Inc.

This privacy policy shall apply to the ***e-Leasing Direct*** website (the ***e-Leasing Direct*** service hereinafter referred to as the “Service” and the ***e-Leasing Direct*** website hereinafter referred to as the “Website”) operated by Mitsubishi HC Capital Inc. (hereinafter referred to as “MHC”). Users of the Service (hereinafter referred to as “Users”) should review and sufficiently understand this privacy policy prior to using the Service and the Website. Any user of the Service shall be deemed to have consented to this privacy policy.

1. User information (including job titles, e-mail addresses, telephone numbers, etc.) shall be provided to MHC when using the Service of the Website. MHC shall register and retain the User information in its system. Use of the Service and the providing of User information to MHC is completely voluntary on the part of the User, and shall constitute consent allowing MHC to use any information provided by the User in accordance with this privacy policy. Users who do not consent to this privacy policy should not provide any User information to MHC.
2. MHC shall use the registered User information solely to provide the Service to the User, as well as to make reasonable improvements to the Service and for other purposes related to the Service.
3. As a general rule, MHC shall not provide registered User information to a third party without the User’s consent. However, there may be occasions when certain User information will be provided to an outsourced developer of the Website for the purpose of improving the Website. In such a case, MHC shall require the third party receiving the information to keep the User information confidential and to refrain from using the User information for purposes other than improvement of the Website.
4. Although links to other websites are included on the Website, MHC shall bear no liability with regard to the content and privacy policies of those websites.
5. Cookies* may be used on the Website only for the purposes described below:
 - (a) To manage the transfer of information between different pages of the Website and to ensure that the same User is viewing the different pages.
 - (b) To prevent unauthorized access and ensure the secure use of the Website by the User.All information contained in the cookies is used for the purposes described above and no cookie contains any information identifying the User. Additionally, Users should note that use of the Website is possible only if cookies are enabled on the User’s web browser.

*Cookies: a technology to extract information from a website and store it on a web browser.
6. MHC may at any time revise this privacy policy and Users should therefore carefully review the policy prior to each use of the Service. If a User uses the Service after MHC has modified the privacy policy, the User will be deemed to have consented to the modified privacy policy.
7. MHC shall respond to reasonable inquiries concerning this privacy policy or reasonable requests for the confirmation, addition, change or deletion of personal information only when MHC is able to confirm the identification of the User.
8. Users of the Website shall be deemed to have consented to the provisions of this privacy policy, and MHC shall bear no liability with respect to any damages suffered by the User from the use of the Website.
